## **Background and Aim**

The workshop is the first engaging activity of the **Policy and Governance Working Group** of the <u>COST Action ENHANCING SMALL-MEDIUM ISLANDS RESILIENCE BY SECURING THE SUSTAINABILITY OF ECOSYSTEM SERVICES (SMILES)</u>. The Working Group aims to review the major policy instruments at the EU and national levels that reflect island sensitivity and contribute to building future island resilience and providing recommendations on policy instruments' improvement with special emphasis on the multi-governance approach. Local specificities and needs of Small-Medium Islands (SMIs) are mainly neglected in policy objectives and natural resources are managed on the basis of policies designed at the national, regional or even global level. In addition to the policy objectives of European Directives (i.e. Water Framework Directive, Marine Strategy Framework Directive, Habitats and Birds Directive) and global policy frameworks such as the Agenda 2023 for Sustainable Development, European islands need to address highly relevant local priorities, which are vital for the well-being of island systems. The workshop aims to explore the policy challenges and existing instruments for addressing socio-ecological vulnerabilities in EU SMIs and to identify potential knowledge gaps.

# **Workshop Objectives**

- Presenting the SMILES COST Action and the Policy and Governance Working Group
- Sharing good practices on resilience and sustainability of small and medium Islands
- Discussing the state-of-the-art knowledge on policy instruments, drivers of changes, and resilience issues on small-medium islands in the EU and global context





- Identifying knowledge gaps and research needs on policy instruments, drivers of changes, and resilience issues on small-medium islands in the EU context.
- To foster networking and collaboration among researchers, working on small-medium islands in the EU and global context

### **Guiding Research Questions**

- Q1. What are the main socio-ecological vulnerabilities in SMIs
- Q2. What are the main existing policy instruments to address vulnerability challenges and enhance socio-ecological resilience to climate change and land use in SMIs paying attention to their specific sensitivity at the EU and national level?
- Q3. What are the main policy actors at the different scales, and if and how they collaborate or coordinate to address socio-ecological vulnerability challenges?
